

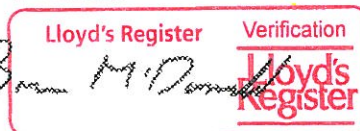

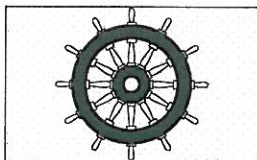

- Maximum clear opening size of damper 200 mm x 200 mm.
- For use in decks only.
- When using fusible link switch/ actuator, Belimo BAE 72 - S, Belimo BF230 - T or Fusible Link SK10/100.
- Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), a Product-Quality assurance system (Module E) or a Product Verification Process (Module F). The wheelmark cannot be affixed to the product until a conformity assessment module is in place.
- This product has been assigned a **U.S. Coast Guard Module B number USCG Approval Category 164.139/EC0038** to note type approval to Module B only as it pertains to obtaining U. S. Coast Guard approval as allowed by the "Corrigendum to Council Decision 2004/425/EC of 21 April 2004 on the conclusion of an Agreement between the European Community and the United States of America on the mutual recognition of certificates of conformity for marine equipment".
